Cass County Hazard Mitigation Plan

- WHEREAS, Jefferson Township, Cass County, Michigan is at risk from hazards that could damage commercial, residential, and public properties, displace citizens, businesses, close transportation routes, and present public health and safety concerns; and
- WHEREAS, members of this community were invited to participate in the review, update, and development of the 2024 Cass County Hazard Mitigation Plan that addresses local hazards including those affecting Jefferson Township and the community's options to reduce overall damage and impact from natural and technological hazards; and
- **WHEAREAS**, an adopted Hazard Mitigation Plan is required as a condition for local units of government to receive funding for hazard mitigation projects; and
- WHEREAS, the Michigan State Police Emergency Management/Homeland Security Division and Federal Emergency Management Agency, Region 5 officials have reviewed the Hazard Mitigation Plan and approved it contingent upon this official adoption by the participating jurisdictions of this plan;

NOW, THEREFORE BE IT RESOLVED, that the Jefferson Township Board hereby adopts the 2024 Cass County Hazard Mitigation Plan as an official plan of Jefferson Township.

The mil percentage may be revisited at the request of either township or the Fire Board at any time. Moved by Mendenhall, seconded by Brunner to approve these amendments. Roll Call Vote: Gillam-yes, Brunner-yes, Hass-yes, Mendenhall-yes.
